REPORTING ADA VIOLATIONS

ATTENTION PROVIDERS, MANAGERS & STAFF

Are you staff at an organization refusing to provide language access for the deaf?

Organizations violating ADA (Americans with Disabilities Act) law and discriminating against the deaf can be reported to the organizations listed on this document, including the US Dept. of Justice.

For ADA violations, maximum civil penalties under title III carry a fine of \$75,000 for the first violation; for each subsequent violation the maximum is \$150,000.

Is it a patient under your care? A client you are responsible for servicing?

If you are complicit in discrimination you may be risking your personal and professional reputation.

You may be risking the professional license of yourself and others.

Insurance providers may not cover legal expenses due to discrimination litigation.

Discrimination lawsuits may result in higher insurance premiums and rates.

If you are staff at an organization, an anonymous report may protect you in the event of discrimination investigations and litigation.

Keep a copy of your anonymous report for your own records.

If discrimination is happening to you, your patients, clients, family or friends you can report it to any of these services.

Don't be part of the problem.

The Joint Commission should be used to report medical service providers, you can also report medical provider violations to US Department of Justice Civil Rights Division and FCC.
